Terms of Reference:

The Oversight Group will be comprised of senior officials (at Assistant Secretary/Director level) from relevant Departments and Agencies, along with representatives of the City and County Managers Association (CCMA), Approved Housing Bodies (AHBs) and other relevant partners.

Building on the political oversight and guidance provided by the Cabinet Committee on Housing, and given the cross-Departmental, inter-Agency focus across all five Pillars of the Plan, the Oversight Group will facilitate wider co-ordination and engagement with key Department/Agency officials and relevant stakeholders.

The Oversight Group's contribution will include assessing progress across the range of policy areas, sharing views on current and emerging challenges and priorities, and informing wider political and administrative consideration of new policies, initiatives and reforms.
