

“DECLARATION” – Ad magorem Dei gloriam - (For the greater glory of God)

I was made in the image and likeness of God. “Man is a creature composed of body and soul”. “God made us to know, love and serve Him here on earth, and, by this means, to be happy with Him forever in Heaven.”

I was given my Christian Names at Baptism. I do not intend to be known as a ‘Number’. “Many Christians, who consider the name given to them in baptism holy, consider it unworthy to ask the government for some new ‘name’ in the form of a ‘number’.” “Christians fear the growing computerisation of the world is opening up the way for the coming of the Antichrist.” “This master plan would imply a system of digital enumeration of each human being of the earth. Thus, the computer would give each inhabitant of the world a number to be used for each purchase” or movement. The identity card with our PPSNs is the next step.” “The promoters of this (coming) cashless society also say that it eliminates any possibility of theft and illegal transactions”. There will be no way to evade taxation!

The ultimate solution in case of loss of the card is a micro-computer chip implanted under your skin; or the number would be invisibly tattooed by laser. This is the plan of the financial and political powers. “Naturally, all of this will be ‘for our own good and/or convenience’.” “The only way to accomplish this is if each Nation surrenders its individual sovereignty to the leadership of a world governing body or leader, who in turn will see to it that all nations will capitulate, either voluntarily or by force, and follow the leader.” “The first thing they must accomplish is to remove as many as possible of our Constitutionally-protected rights and freedoms, legislatively and judicially, in effect making all dissenters “outlaws”. (T.L. Cook – Overview)

INTRODUCTION:

The most fundamental reasons for non acceptance the “Public Services Card” as an Identity are given in the above Declaration.

In this Submission to the Department of Housing, Planning and Local Government’s “Proposed Reforms of the electoral registration process” the two most important issues are **“Identity Verification”** and **“Mandatory Registration”** by way of a **“Public Services Card”**. The **“Public Services Card”** is an instrument for **“Control and Surveillance”** and **“Conquest and Subjugation”**.

A single identification system should not be introduced because it leads to a loss of privacy and electronic bondage. It is an abuse by our Governments who are becoming our “Fearful Masters”.

The Government via the Minister for Housing, Planning and Local Government, “is keen to get the views of as many members of the public (as) are interested in the proposals”. The plans for “Proposed reforms of electoral registration process” are very far advanced and are nearly a fait accompli. The proposals of Minister, Mr John Paul Phelan “aims to make it simpler and ‘more secure’ for people to register to vote”. He states that “The process ... has not changed significantly since the foundation of the State”. So, if it has worked successfully until recent years, why change

it? The Local Authorities have purposely allowed it to descend into chaos. The proposals for 'modernisation' to a so-called 'simpler' and 'more secure' system by use of a new **"Public Service Card"** are deceitful. There is no legislation underpinning the PSC. **"Vague laws are essential to tyranny."**

The adverse impacts of these two important issues are as set out below, namely:

"IDENTITY VERIFICATION" and "MANDATORY REGISTRATION"

A. "IDENTITY VERIFICATION"

The majority of the Minister's seven Key Proposals for modernisation of the "Electoral Registration Process", especially Numbers 5 & 6 are totally objectionable, evil and positively dangerous.

No (5) **"Enabling a single national register database with unique identifiers" –**

Stop the Plans **AND**

No. (6) **"Moving to verified identity using PPSNs" - (possible use of PPSNs)**

Undesirable and must be Stopped

The Minister and Secretary General in the Department of Housing, Planning and Local **Government**, must be aware of the strategy being employed, calculated to deceive and lull the public into believing that only the PPSNs are to be used as "unique identifiers" and to "verify identity". The **"PUBLIC SERVICES CARD"** is the ultimate objective. When that is achieved all other forms of "Identity" will be removed. The Department claims that "Identity Verification" is **"To ensure that people are who they say they are"**. The Irish people are not liars, cheats, swindlers, imposters or forgers and our Governments or Secretary Generals have no right to make such accusations or implications.

No Government has the authority to remove the right of the people to Vote, (for example to Vote such governments out of office), or to disenfranchise most of the people in this country.

"A VOTE" = "A formal expression of choice; individual pronouncement, right to give it, in election or (Referendum); result of voting; that which is given or allowed or granted by Vote

The untruthful emphasis and printing of the words PPSNs throughout the Department's documents are designed to deceive the people of this country. The devious intention is to mandatorily demand production of the **"Public Services Card" (PSC)** in order to Vote.

In the Department's "Short consultation document" and in the longer "Modernisation ... Report" the 'elephant in the room', the new **"PUBLIC SERVICES CARD"** is only mentioned twice in total. Once in the "Short" version, with the words fully typed out on Page 1, and only once in the longer Report as a passing mention in the form of "DEASP Databases" on Page 14. Throughout the "Modernisation ... Public Consultation" document duplicity, double dealing and bad faith is used by

spelling our "**Personal Public Service Numbers (PPSNs)** with only of the full words "**PUBLIC SERVICES CARD**" used once. The abbreviations "**PSC**" is only used in passing when referring to the "Online Option" - "approximately 2.7 million people (who) already have a "**PSC**" so this option will be available to them". It is planned that the "Online Option" will be the **ONLY** option in a short few years to access any government services.

During the "Registration process" for the issuing of a "**PUBLIC SERVICES CARD**" "your photograph and signature will be captured electronically". "The fingerprint match, right hand match is the **KEY** needed to irrevocably tie one in to their super computer ID database." "The combination of two human attributes/characteristics makes all the ID captured, then an unalterable "Identification". The microchip and biochip implants and new ID technology is advancing all the time. The Government and this State have no right to violate our privacy with these "Control" and "Surveillance" – tracking system – electronic bondage that is eroding our liberties and enslaving us." *"He that shall lead into captivity: shall go into captivity."* (C13:V10.)

Any person not in possession of the new "**PUBLIC SERVICES CARD**", containing a spurious number, will be denied **VOTING RIGHTS, HEALTH /HHB ENTITLEMENTS / STATE PENSIONS / BENEFITS / SERVICES / AND ALL OTHER PUBLIC SERVICES**. This same "Process" is aiming to expand the requirement to possess a "**PUBLIC SERVICES CARD**", containing "verified identity" and all of our other private information, ("bring your mobile phone with you for the PSC interview – we want to get that phone number also!) in order to **VOTE**. **THE VOTING RIGHTS OF THE PEOPLE OF IRELAND WILL BE DENIED IF A PUBLIC SERVICES CARD IS NOT PRODUCED.**

The democratic solution to the enslavement planned, is for the Irish Government to "Delete" all the "**PUBLIC SERVICES CARD**" records in the new DSP's Data base and in its "European headquarters", and the similar Databases held in all other Government Departments. Those who wish would then have the option to register themselves for the controversial number!

B. "MANDATORY REGISTRATION"

It has been established that the Department of Employment Affairs and Social Protection do not possess the lawful / legal authority to demand registration for the State services they provide. Hence their use of an "invitation" method, requesting attendance, where they will, without warning, take the intrusive and invasive photographs of parts of the body and obtain a permanent electronic signature. We do not know where all our private information is destined to be stored, shared etc and that ^{it} is impossible to have it removed much less any incorrect formation contained on this PSC corrected or removed.

The people of Ireland have to be protected and preserved from registering for a "universal identification card" or a "unique identifier", which gives each person on this earth a different ID number. "The system is already in place and obvious to all but the most naïve."

"For the first time in history, the technology is available to accomplish the things prophesied in a number of books of the Bible." "Never prior to this generation has any technology been available to

permit the conduct of commerce in the manner described in St. John's *Apocalypse* that he wrote concerning the end times, in Anno Domini 90.

"And he shall make all, both little and great, rich and poor, freemen and bondmen, to have a character in their right hand or on their foreheads." "The Apocalypse" of Saint John Apostle and Evangelist. (Chapter 13: V16)

"And that no man might buy or sell, but he that hath the character, or the name of the beast, or the number of his name." "(Chapter 13: V17)

"Here is wisdom. He that hath understanding let him count the number of the beast. For it is the number of a man: and the number of him is six hundred sixty-six." (C13:18)

Who would have imagined even a few short years ago, that this new **"PUBLIC SERVICES CARD"** would be the instrument that would deprive the people of Ireland, and indeed the people in practically every country around the world, (using a similar type Card) of their rights to WORK, FEED OURSELVES, LIVE, MOVE OR HAVE OUR (THEIR) BEING IN his / FUTURE CASHLESS SOCIETY?

Because, I want to save my immortal soul and get to Heaven, as I am sure the other four and a half million other Irish people want also, I will not allow my bodily integrity to be violated for any digitised images and electronic signature together with physical proofs.

"THE OTHER KEY PROPOSALS" - Undesirable

"Online (ONLY) Registration system for Voters" – Undesirable

Proposal No (3): "Online registration for voters is to be introduced, the Department of Local Government has said." "Online Registration" only will become mandatory within a short timeframe. It is not to be introduced as it is totally objectionable.

"Moving to individual registration only" – Also undesirable

Proposal No (4): "Moving to individual registration only" and away from households would create chaos. Thousands would arrive from nowhere and influence the result at a Referendum. They would be impossible to trace. Also, huge problems would be created with "Anonymous Registration" and the many "other proposals being considered". It is a definite NO to anonymous voters and data sharing. There would be NO "combined benefits" by "data sharing" only a total loss of our privacy.

"Eircodes" - Also undesirable

EIRCODES are another part of the whole track and trace plans by other government department – An Post. An Post recently started demanding PPSNs for their Prize Bonds, Saving Certificates and Bonds and all their financial products and services. I will not use Eircodes! So, does that mean that we will be unable to post or receive mail without using it? Is it an illegal transaction? Checked for

terrorism? The whole universal “Identification Verification” scheme “has mushroomed into a mammoth force to be reckoned with. Don’t make light of it” is very good advice.

The other proposals being considered are objectionable such as:

Registration for young people aged 16-17 through schools without parents’ consent and Anonymous registration.

THE GOVERNMENT PLANS “CONTROL AND SURVEILLANCE” By “Conquest and Subjugation”

According to the Department’s Press Release on 17th December 2018 it is stated that “The proposals arise from a commitment in the “Programme for a Partnership Government” to examine the voter registration process.” This “Programme for a Partnership Government” has no legal, lawful or statutory basis whatsoever on which to base a new “MANDATORY” system for “IDENTITY VERIFICATION”. It is only a voluntary agreement between two political parties.

Democracy or Dictatorship and Enslavement

1. The wishes of the Irish people to continue to exercise their right to cast their free, secret and confidential Vote into the Ballot Boxes at all Elections and at all Referendums must continue. The proposed use of a “Public Service Card Identifier” does away with that right and freedom. Democracy and the Irish Constitution must be respected.

ID Cards – The “Public Services Card” – Abolishes Democracy – This is undesirable

2. The present or any future Government, via the Department of Housing, Planning and Local Government must not be allowed to dictate “by ‘asking’ voters to produce a PPSN number or “Public Services Card” in order to Vote. It is not “the most efficient way of ensuring the register of the electorate is as accurate as possible”. Neither will the Government’s “ID Cards plan stamp out election fraud”. If Local Authorities and their Franchise Sections in recent decades had not neglected their duties and had continued to check the “Register of Electors” on a yearly basis the register would not be in such a mess. Always ‘for our own good do you think’?

“Public Services Card” Abolishes Democracy – It should not be introduced

3. I am totally opposed to a National I.D. in the form of a “Public Services Card”. Cash payments will be loaded on to it and those receiving benefits in the form of cash will in future only be able to ‘buy’ food etc that has been cleared by DSP in the coming future cashless society. Do I need a PSC to participate in this consultation process? If not this time, if the Minister and Government are not stopped, it will be needed? This is a form of State Terrorism and as mentioned previously it has been in gestation for a long number of years now.

“Public Services Card”- An Instrument for a permanent, single “universal identifier”

4. All information gathered on the PSC is an invasion of our privacy. It involves an intrusion of our bodily integrity. On both versions of the “Register of Electors”, – the opt-out and opt-in version – all of our private details are available and “can be used for an electoral or other statutory purpose” as well as by marketing companies. This is an invasion of our privacy.

Will it be an offence to abstain from Voting? The “unique identifier” will be a way of identifying those persons who do not Vote as persons without a PSC, in the future. Persons, and quite a considerable portion of the population, who do not have or do not want a PSC will be disenfranchised and will be unable to Vote. Just like the people who will not be able to buy or sell without the number.

“Polling Information Cards” – “Evidence of Identity” – “PSC” - was added to list

5. It is stated on the reverse side of our “Polling Information Cards” that as “evidence of Identity you are likely to be asked to produce one of the following documents and goes on to list 12 items. The “Public Services Card” is listed as (vii). Up to recently, 11 items for identification were acceptable as “Evidence of Identity”. The PSC has only been added in recent years. This action of adding the PSC as acceptable evidence pre-empts this consultation process is unacceptable. Is this PSC legal or lawful yet? As the “Public Services Card” has not been lawfully sanctioned, acceptance of it as “Evidence of Identity” is out of order. On the “Polling Information Card” it goes on to state that “You are likely to be asked to produce ... further documents to establish address of holder in constituency or local electoral area’. All this ‘requirement’ for ID is totally excessive. We are not all criminals until we prove ourselves not guilty. Who instructed the staff in the Polling Stations to demand ID from one in every 3 or 4 Voters? Staff should not challenge Voters unless they have genuine suspicions that someone is an impersonator. They have not right to ‘accuse’, by implication that a person is committing fraud. Intimidation is the new atmosphere when one goes into the Polling Station now. It is a frightening experience going into a Polling Station nowadays. (Personally, I have had to ask a friend to accompany me to the Polling Station.) Also, some of the questions on the Application Form for Voter registration and on the Supplementary “Register of Electors” are over-intrusive, gathering information on where we lived previously and previous, etc and date of birth. The “Public Services Card” has and will have huge volumes of our personal information – an intrusion of our privacy. The future plan is to make us keep regularly up dating our every move. In different situations for proof of address, only current utility bill(s), Passports etc, and only items current within the last 6 months are acceptable. If no match is found for a person (that person will be hounded/persecuted) to produce documentation. In the United States people are denied their Votes and that is what will happen in Ireland and is unacceptable.

Assurances that laws would protect our privacy ring hollow

6. “With a nation I.D. card your whole life could end up on a government central computer file” in that huge data base in Luxemburg. Networks of Government Departments, semi-

state agencies and unknown entities would have access to our private information. Requirements for constant updating are unsettling. We need to continue to be able to live in peace. The Irish people who are sovereign are entitled to our privacy and to a secret Vote. Our Vote is supposed to be private. With a record of a PPSNs and a **“PUBLIC SERVICES CARD”** number it will be possible to trace and track how people vote. The secrecy of our vote is inviolable/sacrosanct and not to be tampered with. No new reforms are to be brought in that thwart our rights. It would be extremely dictatorial for any Government of this country to set up a ‘process’ that would make it mandatory for Irish people to hold a “Public Services Card” in order to Vote. Indeed, every activity of our lives is being restricted. Even now we are no longer able to function properly unless we have a PSC in our beloved country. **The assurances ring hollow.**

“Costs to the Taxpayer”

Without asking the population in a Referendum on the desirability or otherwise of a **“PUBLIC SERVICES CARD”**, the Government, together with the Secretary General of the Department for Public Expenditure and Reform (via tendering) and the Department of Employment Affairs and Social Protection, went ahead and signed one contract worth E60 million (with a paltry discount of 5% offered) if the Government/the State succeeded in signing up (three) 3 Million Irish people to take a PSC before the end of the year 2018. The biggest offenders are the Department of DEASP and other semi-State agencies such as the RSA. They have terrorised and made all the people dependant on any Social Welfare or State payment, or other State services such as driver and learner permits, and the services of innumerable others semi-state agencies obtain the PSC, by every threat in the book. They seem to have succeeded, but we cannot be sure. Even though the State are well aware of the objections from a huge majority of the people to this unnecessary intrusion of their privacy they press ahead with their plans. With the words ‘Bring your mobile phone with you’, the DEASP tricked people and the elderly into disclosing their mobile number, so that it could be put on the PSC. [Question. Did the DEASP not achieve their aim of giving 3 million people a PSC before 31/12/2018? Did they not get their 5% discount on behalf of the taxpayers?]

“Addition of Further Costs to the Taxpayer”

7. In spite of much opposition to the roll-out of the **“PUBLIC SERVICES CARD” (PSC)**, the Government and Departments signed a further contract for E9 million in order to ‘catch’ the other one and half million that were ‘missed’ in the first round. The second contract went to a different company, and will now proceed to capture these who are presently working. They will be ‘captured’ when they go to renew Passports and Driving Licences etc. All Banks and Financial institutions, Credit Unions etc., are demanding ID in order to take out our own money. Every organisation is demanding I.D., registration. I am totally opposed to a National I.D. in the form of a **“Public Services Card”**. Cash payments will be loaded on to it and those

receiving benefits in the form of cash will in future only be able to 'buy' food etc that has been cleared by DSP in the coming future cashless society. Do I need a PSC to participate in this consultation process? If not this time, if the Minister and Government are not stopped, it will be? This is a form of State Terrorism and as mentioned previously it has been in gestation for a long number of years now.

The Secretary General of the Department for Public Expenditure and Reform (via tendering) and the Department of Employment Affairs and Social Protection, went ahead with the signing of these big contracts totalling nearly ~~10~~ million.

"Voter Registration Problems at Elections and Referendums" – Not solved By PSC

8. Voter Registration problems will not be solved by introducing a "Public Services Card". Neither was the issue of Count Passes to monitor the Count in Referendums solved by the establishment of Referendum Commissions. It is a disaster and costs the taxpayers in the region of Euro E3 to E5 million each time a Referendum is held. It is nearly impossible for groups that are interested in a particular Referendum to have 300 members, register in the Company Registration Office and apply for approval to the Referendum Commission within the short time frame from the date of the announcement of each new Referendum. People or groups interested in the newest Referendum may not have been involved or established previously. The rules devised by the Department of the Environment in the past do not allow interested group to Monitor the Counts and the Government are aware of what can happen to Ballot Boxes and Voting Papers if the process is not properly monitored.

RECOMMENDATIONS

The State, the Government and all Government Departments and in this case, The Minister and the Minister and Minister for State at the Department of Housing, Planning and Local Government and semi-State agencies must abandon the whole concept of "Unique identifiers" such as the "**PUBLIC SERVICES CARD**" in Ireland. An I.D. was introduced in the UK but was stopped and abandoned by an incoming new Government in the past. This will have to happen so that our country can remain a Democracy and not become a Dictatorship. This is where the "**THE PUBLIC SERVICES CARD**" is leading us presently.

SUMMERY

By the Grace of God, we live and work and have our being. We do not belong to the controlling, tracking and hidden 'forces' of this world for their 'profit'. Totalitarian "Control and Surveillance" of the all people in this country – "Conquest and Subjugation" of the entire population of this earth – is their ultimate aim.
