**Dáil Éireann (Bye-Elections) Order 2019**

Maidir leis an vótaíocht sa toghchán a dhéanfar do chomhalta de Dháil Éireann chun an folúntas i gcomhaltas Dháil Éireann a líonadh, is folúntas a luaitear san eascaire a eisíodh chuig an gceann comhairimh do dháilcheantar Bhaile Átha Cliath-Fhine Gall an 7 Samhain 2019, tógfáir í an 29 Samhain 2019 agus leanfaidh sí ar aghaidh ar feadh na tréimhse idir na huaireanta 7 a.m. agus 10 p.m.

I, Eoghan Murphy, Minister for Housing, Planning and Local Government, in exercise of the powers conferred on me by section 96 of the Electoral Act 1992 (No. 23 of 1992), order as follows:-

1. This Order may be cited as the Dáil Éireann (Bye-Elections) Order 2019
2. The poll at the election to be held of a member of Dáil Éireann to fill the vacancy in the membership of Dáil Éireann mentioned in the writ issued on 7 November 2019 to the returning officer for the constituency of Cork North-Central shall be taken on 29 November 2019 and shall continue for the period between the hours of 7 a.m. and 10 p.m.
3. The poll at the election to be held of a member of Dáil Éireann to fill the vacancy in the membership of Dáil Éireann mentioned in the writ issued on 7 November 2019 to the returning officer for the constituency of Dublin Fingal shall be taken on 29 November 2019 and shall continue for the period between the hours of 7 a.m. and 10 p.m.

4. Maidir leis an vótaíocht sa toghchán a dhéanfar do chomhalta de Dháil Éireann chun an folúntas i gcomhaltas Dháil Éireann a líonadh, is folúntas a luaitear san eascaire a eisíodh chuig an gceann comhairimh do dháilcheantar Bhaile Átha Cliath Thiar-Meán an 7 Samhain 2019, tógfáir í an 29 Samhain 2019 agus leanfaidh sí ar aghaidh ar feadh na tréimhse idir na huaireanta 7 a.m. agus 10 p.m.
5. Maidir leis an vótaíocht sa toghchán a dhéanfar do chomhalta de Dháil Éireann chun an folúntas i gcomhaltas Dháil Éireann a líonadh, is folúntas a luaitear san eascaire a eisíodh chuig an gceann comhairimh do dháilcheantar Loch Garman an 7 Samhain 2019, tógfáir í an 29 Samhain 2019 agus leanfaidh sí ar aghaidh ar feadh na tréimhse idir na huaireanta 7 a.m. agus 10 p.m.
4. The poll at the election to be held of a member of Dáil Éireann to fill the vacancy in the membership of Dáil Éireann mentioned in the writ issued on 7 November 2019 to the returning officer for the constituency of Dublin Mid-West shall be taken on 29 November 2019 and shall continue for the period between the hours of 7 a.m. and 10 p.m.
5. The poll at the election to be held of a member of Dáil Éireann to fill the vacancy in the membership of Dáil Éireann mentioned in the writ issued on 7 November 2019 to the returning officer for the constituency of Wexford shall be taken on 29 November 2019 and shall continue for the period between the hours of 7 a.m. and 10 p.m.
